15 Pursuant to Government Code Section 11440.50, the presiding officer in an
16 administrative hearing shall, upon motion, grant intervention to an applicant if the conditions of
17 that section have been met. GCL, LLC filed a motion for intervention electronically, with
18 electronic service upon the representatives of the parties to this proceeding, on March 25, 2016.
19 GCL, LLC is the owner of the real property and is subject to the terms and conditions of the
20 relevant Solid Waste Facility Permit -- both of which are at issue in this proceeding. As such, the
21 outcome of this proceeding will have a direct bearing on the legal rights and duties of GCL,
22 LLC. I find that there exists proper grounds for intervention. In order to avoid impairing the
23 orderly and prompt conduct of this proceeding, GCL, LLC shall comply with the original

1 timelines in the Amended Notice of Hearing for written argument. The “Response of Real Party
2 In Interest, GCL, LLC” that was filed by the applicant on March 25, 2016 shall be considered its
3 opening written argument as it was filed in a timely manner consistent with the Amended Notice
4 of Hearing. Should a live hearing be scheduled, GCL, LLC will be permitted to participate as
5 Real Party in Interest. All evidence in the administrative record before the LEA and the local
6 hearing panel will be considered in this proceeding. Consistent with Government Code Section
7 11440.50(d), this order may be modified at any time.

8 The motion for intervention is hereby granted.
