17 TO THE RESPONDENT, SAC SCRAP, LLC. You are hereby notified that
18 before an Administrative Law Judge a trial shall be held on January 28 and 29, 2013,
19 at 9:00 a.m. at Office of Administrative Hearings, 2349 Gateway Oaks Drive, Suite 200,
20 Sacramento, California, 95833, or as soon thereafter as the matter may be heard, upon
21 the charges made in the Statement of Issues for the Denial of the Minor Waste Tire
22 Facility Permit served upon you. If you object to the place of hearing, you must notify
23 the presiding officer within 10 days after this notice is served on you. Failure to notify
24 the presiding officer within 10 days will deprive you of a change in the place of the
25 hearing. You may be present at the hearing. You have the right to be represented by
26 an attorney at your own expense. You are not entitled to the appointment of an
27 attorney to represent you at public expense. You are entitled to represent yourself
28 without legal counsel. You may present any relevant evidence, and will be given full

1 opportunity to cross-examine witnesses testifying at hearing against you. You are
2 entitled to the issuance of subpoenas to compel the attendance of witnesses and the
3 production of books, documents, or other things by applying to the Office of
4 Administrative Hearings, 2349 Gateway Oaks Drive, Suite 200, Sacramento, California
5 95833. Pursuant to section 11513 of the Government Code, parties are entitled, upon
6 request, to be provided with the assistance of an interpreter if they do not proficiently
7 speak or understand the English language. If you require the assistance of an
8 interpreter; timely notice of this fact should be given to the agency conducting the
9 hearing so that appropriate arrangements can be made.

11 CONTINUANCES: Continuances are not favored. If you need a continuance, write or
12 call immediately to the Office of Administrative Hearings, 2349 Gateway Oaks Drive,
13 Suite 200, Sacramento, California 95833, telephone number (916) 263-0550. That
14 agency has control of continuances. Requests coming less than 30 days before
15 hearing, or a request without good cause, will be denied.
